## ADJUTANT GENERAL'S CORP PRESENTATION IN HENRY VIII'S WINE CELLAR

**THURSDAY 16<sup>th</sup> MAY 2019**

Through our affiliation with the Management Accountancy Unit of the Adjutant General's Corp we have been invited to present an award for "the Most Significant Contribution" made by a Servicemen to the unit.

The presentation will take place in the former wine cellar of Henry VIII and this is located deep underneath The Ministry of Defence in Whitehall. It is pretty amazing that this Cellar from the Palace of Whitehall survived. Not only were the buildings above it razed several times by fire in the 16<sup>th</sup> and 17<sup>th</sup> century, and by 18<sup>th</sup> and 19<sup>th</sup> Century development, but the original plans for the new MoD buildings and the surrounding roads would have meant the destruction of the Cellar. It was Queen Mary, the widow of George V, who requested that it be saved. You will find out how this architectural treasure survived on the visit.

It is not open to the public and is a secure area, consequently we will need to provide our passport details in advance of the visit (please provide a copy of the information page on booking) and we will be escorted through the building in groups of 4. Space is limited to a maximum of 27 and as this is a truly unique event, preference will be given to Liverymen.

The presentation will include a drinks reception and afterwards we will adjourn to the National Liberal Club and entertain our affiliated officers for a three course dinner. Founded in 1882 by William Ewart Gladstone, the National Liberal Club is housed in an extraordinary building by noted Victorian architect Alfred Waterhouse. Overlooking the Thames, with "the most splendid terrace in London" our dinner will be in the Lady Violet Room.
