## SHROVE TUESDAY PANCAKE RACES Runners and spectators needed!

The Worshipful Company of Tax Advisers invite runners and spectators to the City's annual inter-livery Pancake Race on Shrove Tuesday 13 February 2018.

The event starts at 12noon and sees 21 teams racing around the Guildhall yard competing for frying pan trophies awarded to the winner of each class. It's a colourful event organised by the Poulterers' Company, who supply the eggs - essential in the making of the pancakes - with the support of The Cook & The Butler. Every other aspect of the race is allocated to the relevant livery - the Gunmakers start each heat with a bang, the Clockmakers are responsible for the accuracy of the timing, the Fruiterers provide lemons, the Cutlers plastic forks, the Glovers the white gloves worn by each runner and of course, the Firefighters!

We have entered teams for the last 9 years and are looking forward to a winning year in 2018 (we have never won a trophy yet in spite of reaching the finals many times over!).

We need a team of 4 runners comprising of the Master, a Liveryman, a lady Freeman or Liveryman and a fancy dress entrant in the theme of the Lord Mayor's chosen charity. The Master will be running, we just need three other sprightly volunteers and as many spectators as possible.

A stand up buffet lunch is served after the event in the Crypt of Guildhall at a cost of £30 per person. This is open to all runners and spectators. Lunch concludes by 2:15 and everyone attending the lunch receives a commemorative mug.
