Hon David Gauke MP, who spoke and is now Chief Secretary to the Treasury. A special occasion for me personally was seeing Past Master Erica Stary elected as Master Plumber at the church of St. Magnus the Martyr. The last official function for me were the events to commemorate the Great Fire of London and pleased to report that our company supported these and all were successful, including the burning of the specially built construction on the Thames.
